Expression of Interest (EoI) for conducting CBT in UKSSSC, Govt. of Uttarakhand

The Uttarakhand Subordinate Services Selection Commission (UKSSSC) at present conducts all its recruitment through offline mode exams. It proposes to conduct, on a pilot basis, Computer Based Tests (CBT) for selection to various government posts in the state of Uttarakhand. UKSSSC now invites expression of interest from eligible registered companies (No Consortium or private partnership) with unblemished records. The Service provider is expected to give complete solution and conduct CBTs for UKSSSC. The exam conduction may include important activities such as invitation of online applications, arrangement for exam centers, preparation of question papers, actual conduct of CBT, result preparation etc.
